I. CALL TO ORDER, PLEDGE OF ALLEGIANCE, AND RECESS TO CLOSED SESSION

President Giraud called the meeting to order at 5:30 p.m. and Chief Johnson led the Pledge of Allegiance. Directors in attendance: Bennett, Durante, Giraud, Hartley, and White. Staff in attendance: Chief Johnson and Director of Finance Braddock. Counsel Cook was also in attendance.

Meeting adjourned to closed session at 5:31 p.m.

The meeting reconvened at 6:03 p.m. The Board took no action during closed session.

Director Durante made a motion to approve the consent calendar, seconded by Director Hartley and unanimously carried.

sustainability of the CalPERS pension system.

- A. EDH Development Snapshot** – Fire Marshal Cox presented a slideshow covering current development projects in El Dorado Hills.

VIII. COMMITTEE REPORTS

- A. Administrative Committee (Directors Durante and Hartley)** – No report.

B. Finance Committee (Directors Giraud and White)

- 1. Review and approve MOU Side Letter regarding Station 91 Staffing** – Chief Johnson Stated that staff recommends replacing the patrol with a Type 1 Engine to increase safety and service to the community.

Director Hartley made a motion to approve MOU Side Letter regarding Station 91 Staffing, seconded by Director Durante, and unanimously carried.

- 2. Review and approve MOU Letter of Clarification regarding “Education Pay”**– Chief Johnson reported that State Fire Training changed the requirements for the Fire Officer certification and the proposed letter clarifies the intent of the MOU, which is to pay employees based on the completion of the required courses, not the position held.

Director Durante made a motion to approve MOU Letter of Clarification regarding “Education Pay,” seconded by Director Bennett, and unanimously carried.

- 3. 2018/19 Mid-Year Budget Review** – Director of Finance Braddock summarized the mid-year budget review stating that it is trending on target.
- 4. 2019/20 Budget Timeline** – Director of Finance Braddock stated that the Finance committee discussed a timeline for the budget process and the plan is to present the preliminary budget for review at the May Board meeting.
- 5. Review and approve revised Rescue Shared Services Contract** – Chief Johnson presented a revised Shared Services Agreement that extends through December 31, 2019, adding that the major change is that Chief

Keating will no longer be available to offer Deputy Chief services as of March 31, 2019. Director Durante asked what compensation the District would be getting from Rescue and Chief Johnson responded that no monetary compensation would be given, but the District would have access to Rescue's Administrative Assistant as needed.

Director White made a motion to approve revised Rescue Shared Services Contract, seconded by Director Hartley, and unanimously carried.

6. **Approval of a change to the Rules and Regulations from an 18-month to a 12-month Firefighter/Paramedic probation timeframe** – Chief Johnson explained that best practice in the fire service is to have a 12-month probationary period and recommends that the rules and regulations be updated to reflect a 12-month probation for the Firefighter/Paramedic rank.

Director Bennett made a motion to approve a change to the Rules and Regulations from an 18-month to a 12-month Firefighter/Paramedic Probation timeframe, seconded by Director Durante, and unanimously carried.

7. **Direct staff to conduct a Rescue Annexation Feasibility Study/Plan for Service** – Chief Johnson asked that the Board direct Staff to do a thorough feasibility study of the potential annexation of Rescue Fire Protection District.

Richard Ross, resident, asked that staff have a meeting with the public to find out what the citizens would like to see presented in the study. Chief Johnson explained that there will be multiple opportunities for the public to be a part of the discussion prior to any official decision.

Director Hartley made a motion to direct staff to conduct a Rescue Annexation Feasibility Study/Plan for Service, seconded by Director Bennett, and unanimously carried.

8. **Discuss upcoming contract negotiations and appoint Chief Johnson to negotiate on the Board's behalf** – Chief Johnson stated that he and the Union have a great working relationship and he recommends that the Board designate him as the lead negotiator for the upcoming contract negotiations. Director White reported that the Finance Committee supports the Chief's recommendation.

Director Bennett made a motion to appoint Chief Johnson to negotiate

on the Board's behalf, seconded by Director White, and unanimously carried.

- IX. FIRE CHIEF'S REPORT** – Chief Johnson updated the Board on the deficiencies in the County communications system. Captain MacKenzie gave a report on the options that the District has looked at for communications solutions and his recommendation that the District hire a consultant to study the needs of the Department. He added that an official recommendation will come to the Board for approval to move forward.

Chief Johnson stated that the County has put together a group together to discuss fire service sustainability. He reported that Staff is a part of that discussion and the Fire Chiefs in the County have decided to have those discussions with the local board members and labor groups and then bring their solutions/recommendations to the County.

Chief Johnson stated that the County is looking at a vegetation management ordinance and Fire Marshal Cox is involved in those conversations with specific concerns about safety and feasibility.

Chief Johnson reported that the District will be hosting a Sacramento Homeland Security drill and more information will be presented as it comes. He anticipates it will attract a lot of media surrounding the event and it will be a benefit to the District.

Chief Johnson continued in briefing the Board on the following topics: the HR Director recruitment flyer has been posted and is getting a great amount of interest; employee John VanDalen, Firefighter/Paramedic, will be representing the District on the Firescope EMS Specialist Group; the annual report workshop will likely be held in April or May; and Staff is looking into the Department joining the statewide FEMA USAR team.

X. OPERATIONS REPORT

- A. Operations Report (Receive and file)** – Director White asked that the deployment measures be presented in the Operations report even if the information is not all available or completely accurate.

XII. NEW BUSINESS

- A. Review and approve changes to the Unimproved Property Hazard Abatement Program Standard** – Fire Marshal Cox asked that the Board approve the proposed change to the Unimproved Property Hazard Abatement Program Standard increasing the clearance from 100 feet to the whole parcel up to one acre. Director White recommended a few changes for clarity in the document.

Director Durante made a motion to approve changes to the Unimproved Property Hazard Abatement Program Standard including Director White's recommendations, seconded by Director White, and unanimously carried.

- XIII. OLD BUSINESS** – Director White asked about any follow-up about DOT looking at the Bass Lake site. Chief Johnson reported that discussions are still happening, and he will update the Board when he has more information.

XIV. ORAL COMMUNICATIONS

- A. Directors** – Director Hartley complimented the Director of Finance on the Budget timeline document. Director Giraudo stated that Director Hartley has decided to give his seat on the Admin committee to Director Bennett.
- B. Staff** – None.
- C. Schedule upcoming committee meetings** – A tentative Special Meeting was scheduled for March 14, at 5:30 p.m.

XV. ADJOURNMENT

Director Durante made a motion to adjourn the meeting, seconded by Director Hartley, and unanimously carried.





RESOLUTION 2019-01

**Resolution of the Board of Directors to Exercise its Statutory Authority
to Abate Weeds on Properties on which said Weeds Constitute a Public Nuisance**

WHEREAS, the El Dorado Hills County Water District Board (Fire Department) has the authority pursuant to Section 13879 and Section 14875 et seq., of the Health and Safety Code, to declare weeds a public nuisance and abate said weeds; and

WHEREAS, “weeds” are defined as all weeds growing upon streets, sidewalks, or private property in any county, including any fire protection district and including any of the following: (a) weeds which bear seeds of a downy or wingy nature; (b) sagebrush, chaparral, and any other brush or weeds which attain such large growth as to become, when dry, a fire menace to adjacent improved property; (c) weeds which are otherwise noxious or dangerous; (d) poison oak or poison ivy when the conditions of growth are such as to constitute a menace to the public health; (e) dry grass, stubble, brush, litter, or other flammable material which endangers the public safety by creating a fire hazard; and

WHEREAS, the El Dorado Hills County Water District desires to abate weeds in the District as described in those certain EDHCWD resolutions dated March 19, 1997, and April 15, 1988, and in accordance with the Vacant Lot Weed Abatement Standard developed by the District.

NOW, THEREFORE, the EDHCWD (Fire Department) resolves as follows:

1. **Declaration**: The EDHCWD (Fire Department) hereby declares that weeds growing upon streets, sidewalks and private property on or near the properties described herein below are a nuisance to the public.
2. **Description of Properties**: (See attached Exhibit “A”).
3. **Enforcement**: The EDHCWD Fire Chief, or any employee or agent of the Fire District appointed by the Fire Chief, has the authority to enforce the abatement procedures established herein.
4. **Notice**: The EDHCWD (Fire Department) shall abate said weeds in accordance with the notice requirements of Chapter 3 (commencing with Section 14890) of Part 5 of Division 12 of the California Health and Safety Code by posting and publishing the notice of hearing on the properties affected thereby or by mailing same to the property owner as established by assessment rolls.

5. Assessments: The amount of the cost for abating the weeds and the amount of the cost incurred by the Fire Department in enforcing abatement including investigation, boundary determination, measurement, clerical and other related costs shall constitute special assessments against the property from which removal occurs and are a lien on the property for the amount of the respective assessments. The assessment may be collected at the same time and in the same manner as ordinary municipal ad valorem taxes are collected. After the report on the determination of the assessment is confirmed by the Board pursuant to Sections 14910 and 14911 of the California Health and Safety Code and the report is thereafter turned over to the County Auditor, the assessment shall then be collected at the same time and in the same manner as county taxes are collected and are subject to the same penalties and the same procedure for sale in case of delinquency as provided for ordinary county taxes.



District Growth Summary

The District experienced healthy growth in 2018. Property tax revenue, District assessed value, and development fees all increased from 2017. Highlights are as follows:


- ❖ The assessed value for the District increased 7.62% in fiscal year 2018/19. This is the seventh consecutive year the District has had an increase in assessed value. The District assessed value has increased an average of 7.95% per year over the past 5 years and 2.77% per year over the past 10 years.
- ❖ The District's property tax revenue, including projections provided by the County, is expected to increase by approximately 8.86% for the 2018/19 fiscal year. Property tax revenue has increased an average of 7.87% per year over the past 5 years and 2.77% per year over the past 10 years.




- ❖ Permits were issued in 2018 for commercial development totaling 184,672 square feet, a 91% increase from 96,925 square feet in 2017. Residential development decreased by about 54% in 2018 to roughly 1,661,234 square feet. Residential and commercial development combined added approximately \$188,170,293 in assessed value to the District.



- ❖ New home development was down with 413 homes constructed, a decrease from the last three years. The District had a total of 17,006 homes at the end of 2018.



2018 TOTAL HOMES BY RESPONSE AREA



- ❖ The District billed a total of \$1,608,093 in development fee revenue during the 2018 calendar year, a decrease from the last three years.




In summary, while new construction and development fee numbers were lower in 2018 than in the preceding years, the District continues to grow steadily at a positive rate and has fully recovered from the economic downturn of 2009. The assessed value of the District is at an all-time high and continues to trend upward. The Department remains proactive in meeting the ongoing challenges it faces to manage the growth and development needs in our community.

District Financial Summary

The District maintains a healthy financial position by budgeting prudently and adjusting spending when needed. Below is a summary of the 10-year historical trends in Revenue, Expenses and Reserve Balances.

REVENUE


The District's primary source of revenue is property tax revenue, which is projected to make up approximately 82% of total revenue in 2018/19. Property tax revenue has steadily increased year over year since its 10-year low in fiscal year 2010/11. While property tax revenue is projected to increase by approximately 6.56% in 2018/19, total revenue is projected to decrease by approximately 1.2%. This slight decrease is due to a projected decline in development fee revenue. OES and JPA revenue consist of reimbursements for actual costs incurred and have remained relatively flat over the years. Other revenue is mostly made up of interest income, which has seen an increase in recent years due to rising interest rates.



EXPENSE


The District prides itself on maintaining a tight control over expenses and on having the ability to adjust and reduce spending when needed. Accordingly, the 10-year trend for total expense shows fluctuations year over year that are consistent with the increases and decreases in total revenue. During the years of declining revenue due to the economic downturn, the District's investment in capital assets was significantly reduced. Staffing adjustments were also made during this time, which is clearly shown in the Wages & Benefits cost trend.

Wages & Benefits have since increased year over year as the District has recovered from the economic downturn. Investments in fixed assets have fluctuated greatly depending on the timing of large projects, such as the rebuild of Station 84 in 2014-2016 and a new Type I Engine purchased in 2018/19. Other Operating Expenses consist primarily of insurance, maintenance and professional services. These costs fluctuate based on major maintenance projects or special projects requiring consulting services in any given fiscal year. There is a spike in total expense budgeted for 2018/19, which is due to planned lump sum payments toward the District's Pension and OPEB unfunded liabilities totaling \$2.1M, as well as higher budgeted fixed asset purchases for a Type I Engine.



RESERVE BALANCES

The District has historically maintained healthy reserve balances, meeting its Reserve Policy goal of keeping a minimum of half a year’s operating expense on hand in the General Reserve Fund. The 10-year historical trend shows total reserves holding steady at around \$20M from 2010/11 to 2015/16. In 2016/17 and 2017/18, reserve balances increased to \$23M and \$27.9M, respectively. Balances are projected to rise further to \$28.9M by the end of fiscal year 2018/19. However, these increases are mostly due to growth in the restricted Development Fee Reserve Fund. General and Capital Replacement Reserve Funds have declined from a high of \$21.6M in 2009/10 to a budgeted \$19.9M in 2018/19. The District continues to monitor these trends with an overall goal of preserving its unrestricted reserves and meeting the goals set forth in its Reserve Policy.





Calls for Service

Calls for Service

The El Dorado Hills Fire Department responds to all incidents including medical emergencies, fires, hazardous materials, technical rescues and public assistance. We continue to be an active partner in the “closest resource” response model in El Dorado County. We also provide automatic aid/mutual aid on a reciprocal agreement with our neighboring counties.

4,404 CALLS FOR SERVICE

Over the years, the population of our service area has increased and so has the request for service. In the year 2018, the El Dorado Hills Fire Department responded to a total of 4,404 calls for service. This is an increase of 8% from 2017.

\$10,180,509,014 ASSESSED VALUE PROTECTED

The Department protects over \$10 billion dollars in assessed land and structure value, which is the highest value in all El Dorado County. In 2018, the Department responded to 136 fire incidents that resulted in a dollar loss of \$2,203,656 and a dollar saved of \$31,209,666 which equates to a total ***percentage saved of 93%***. This savings can be attributed to the Department’s high level of training and commitment to provide exceptional levels of service.

50,000 ESTIMATED POPULATION PROTECTED DAILY

Through continued evaluation of our response plan, utilization of resources, and use of the latest technology, the men and women of the El Dorado Hills Fire Department will continue to serve the community with integrity and excellence.






TYPE OF INCIDENTS BY YEAR




PERCENTAGE OF ALARMS




MEDICAL AID ALARMS




ALARMS PER MONTH




ALARMS PER YEAR




ALARMS PER DAY

Training & Emergency Services

Training & Emergency Services

The mission of the El Dorado Hills Fire Department Training Division is to provide the highest level of training for emergency and non-emergency services to the members of the Fire Department. This will ensure that our commitment to the community is met and our commitment to our personnel is fulfilled. This mission aligns with our Department mission statement: "We, the El Dorado Hills Fire Department, exist to serve and protect the Community through emergency management."

The Training Division has committed to maintaining a high skill level of Department personnel and is committed to meeting or exceeding industry standards for training. For example, the ISO (Insurance Service Office) industry standard requires twenty hours of fire-based training per month. This is accomplished through single engine company and multi-company drills encompassing everything from hose evolutions and vehicle extrication to wildland fire drills. The division is also focusing on continuous medical training for the crews so they are current on new concepts and techniques.

Training is generated and assigned by the Training/EMS Captain with the assistance of the Training Administrative Assistant. With oversight by the Shift Battalion Chiefs, it is the Captains' responsibility to complete the training with their crews. The Training Division provides a global training calendar for the year to give the crews an idea of the scheduled training to come. Each month, a detailed list with instructions is assigned with specific training objectives. This schedule ensures the division is meeting the industry standards for training while meeting the crews' personal training needs.

2018 Training Highlights

- The Department hosted and conducted a two-day, hands-on course in responding to the Active Shooter for all emergency response personnel with our law-enforcement partners from the El Dorado County Sheriff's Department, Folsom Police Department, California Highway Patrol, and California State Parks.
- Seven new-hire Firefighter/Paramedics completed an eight-week Academy that included certification in Low Angle Rope Rescue, Vehicle Extrication, Hazardous Materials Abatement, and Swiftwater Rescue Operations.
- Three Firefighters completed Rescue Systems 1 training (rope systems and building collapse shoring).
- One Firefighter completed Rescue Systems 3 training (advanced shoring and collapsed structure rescue).
- Six Firefighters completed Rescue Boat Operator training, (certified in operating inflatable and rigid hull rescue watercraft).
- One Firefighter completed Rope Rescue Technician certification (advanced and complex high-angle rope rescue).
- Twelve Firefighters completed Swiftwater Rescue Technician certification (certified for in-water rescue in swift and flood waters).

Explorer Program

The El Dorado Hills Fire Explorer program is an opportunity for local high school students to receive first-hand experience and training with professional El Dorado Hills Firefighters. The program's purpose is to expose young men and women to all aspects of the fire service, beginning with entry level interviews and moving into developing skills associated with the everyday tasks to which Firefighters are exposed.

The EDHFD Explorer program's inception began in 2013 under the vision of Firefighter Jeno Inzerillo. Firefighter Inzerillo saw the need for curious high school aged students to be exposed to the rigors and reality of a career in the fire service. Similar programs existed in other parts of the county, but nothing was established in El Dorado Hills. Beginning with bi-monthly meetings at Station 86, students began participating in an academy-like atmosphere with lectures and weekend drills.

Today, the Explorer program has grown into a weekly drill schedule where Explorers are training and exposed to much of the same tasks as the professional Firefighters of EDHFD. Drills are now held at all stations in the district, depending upon the topic and equipment needs. These drills are designed to be a progressive type of instruction where skills are developed and improved upon, exposing the Explorers to more and more strenuous tasks. Explorers now routinely put multiple skills together to perform not just singular tasks, but complex fire and rescue scenarios with multiple moving parts.



In addition to these weekly drills, Explorers are involved with community service projects including the Santa Run, Boys and Girls club events, Firefighters Burn Institute "Fill the Boot" drive, and other needs supported by EDHFD.

The Explorer program has opportunities for 20 students aged 16-20 from Folsom, Vista, Ponderosa and Oak Ridge High Schools and is currently run by a cadre of advisors consisting of seven professional El Dorado Hills Firefighters.

Honor Guard

2019 marks the completion of The El Dorado Hills Fire Department Honor Guard's 15th year of service. Peter Bertelsen Memorial Park, El Dorado Hills Little League Baseball opener at Jeff Mitchell Field, El Dorado Hills Senior Center Veterans Day event, and the retirement ceremony for Chief Roberts from El Dorado Hills FD.

We are excited to continue our tradition of service into 2019 and look forward to representing this great department whenever needed.

The El Dorado Hills Firefighters Pipes and Drums was formed in 2011 by nine members of the El Dorado Hills Fire Department. The inception of the band was created out of a desire to honor the rich tradition of culture in the fire service. The tradition of bagpipes played at Fire and Police Department funerals in the United States goes back over one hundred and fifty years. When the Irish and Scottish immigrated to this country, they brought many of their traditions with them. One of these was the Great Highland Bagpipe, often played at Celtic weddings, funerals and ceilis (dances).

It wasn't until the Great Potato Famine and massive Irish immigration to the East Coast of the United States that the tradition of the bagpipes really took hold in the Fire Department. In the 1800's, Irish immigrants faced massive discrimination. Factories and shops had signs reading "NINA" - No Irish Need Apply. The only jobs they could get were the ones no one else wanted - jobs that were dirty, dangerous, or both - Firefighters and Police Officers. It was not an uncommon event to have several firefighters killed at a working fire. The Irish Firefighters' funerals were typical of all Irish funerals - the pipes were played. It was somehow okay for a hardened Firefighter to cry at the sound of bagpipes when his dignity would not let him weep for a fallen comrade.

Those who have attended a funeral where bagpipes were played know how haunting and mournful the sound of the pipes can be. The most famous song played at fire and police funerals is Amazing Grace. It wasn't too long before families and friends of non-Irish Firefighters began asking for the bagpipes to be played for fallen heroes. The bagpipes add a special air and dignity to this solemn occasion.

Today, the tradition is universal and not just for the Irish or Scottish. The bagpipes have become a distinguishing feature of a fallen hero's funeral. The El Dorado Hills Firefighters pipes have chosen a Celtic saying as our motto, "Ne Oublie", which translates "never forget". Our goals as a band are to honor those who have served first and foremost through funeral performances as well as retirements etc. We also perform for community events such as parades, youth sports, dedications, and holiday celebrations.

2018 was another great year for the Pipes and Drums. We were able to honor retirees and other members of the service throughout the year and we look forward to another great year in 2019. The band will be making its trip back to Colorado Springs to attend the Annual Fallen Firefighters Memorial in September. We look forward to representing EDHFD!

Fire Prevention and Safety

Fire Prevention

In 2018, the Fire Prevention Division once again experienced an increased demand for prevention services. This year's demand was more focused on planning and development projects in preparation for a projected large building year in 2019. The services provided included increases in development planning, project approvals, plan reviews, inspections, business license applications, tenant improvements, and public education.

The Fire Prevention Division includes Marshall Cox (Fire Marshal), Dan Skubal (Fire Prevention Specialist), and Stephanie Layton (Fire Inspector II). The division has added to the new plan review technology in 2018 that included a second iPlan Table. These iPlan Tables allow all aspects of plan review to be completed faster and more efficiently than paper plans. "Going digital" has not only helped serve the Fire Prevention Division's mission of accurate and timely reviews, but has also allowed us to better serve our community members. Digital plan submittals allow for reduced gasoline usage, lowering or eliminating travel time, and paper savings that would normally be spent on printing services. The digital plan submittal process provides a secure way to submit plans electronically or use an online account for plan links. In 2018, we bolstered our plan submittal process by creating web portals for customers to use to submit plans based on the plan type. These categories include Development/Civils, Building Construction/Fire Protection Systems, Special Events, and TUP/CUP/SUP projects.

Vegetation Management and Wildland Fire Safety remain paramount focal points for the El Dorado Hills Fire Department. We have added to and updated our website to include more safety tips, flyers, and information for our community members to easily access. In addition, we have grown our local relationships with stakeholders to collaboratively provide services that directly benefit the residents, HOAs, agencies, and community of El Dorado Hills. The Lakehills Fire Safe Council has continued its extraordinary efforts in actively pursuing grant funding and executing fuel reduction projects which include a shaded fuel break along Folsom Lake, completing a Community Wildfire Protection Plan, and becoming a FireWise Community. The hard work of the Lakehills Fire Safe Council and its dedicated leadership team deserves special acknowledgement, year in and year out.


New construction continues in El Dorado Hills with the addition of two new Care Facilities, a Safeway Center, Arco gas station, Self-Storage facility, warehouses, business buildings in the business park, and waste management facilities. Care facilities include the Pavilions off of Francisco Drive and Green Valley Road, Oakmont off of Town Center West Way and White Rock Road, future plans for Westmont Care off of Carson Crossing Drive and Golden Foothill Parkway, and a commercial site off of St. Andrews Drive. The Town Center El Dorado Hills Apartments, Montano De El Dorado II expansion, and the many new residential subdivisions that are actively moving through the various Fire Prevention Division processes will lead to a very demanding 2019. This includes construction plan review, inspections, and testing of numerous buildings throughout the district.

Prevention programs ran strong, fast, and smooth as we closed out 2018. These programs include Business Inspections, Hydrant Inspections, Public Education, Buckle Up Baby, Vacant Lots, Hazard Reductions, Fire Prevention Officers, and Fire Safe Councils. Hydrant inspections on the iPad are the next big task ahead of Prevention for 2019 (continued from 2018). We are working with EID to update all GIS maps by inspection district per station and shift. As the elderly community demographic continues to grow in El Dorado Hills over the next few years, the need for Public Education and services is on the rise. Prevention will monitor the need and demand for services, as well as ensure the maintenance and growth of current programs that benefit the citizens of EDH. Program outreach and growth may require the future need of Prevention personnel to ensure program sustainability, a high level of service, and fire safety projects that impact the citizens, employees, and firefighters of EDH.




ANNUAL FIRE LOSS (Estimated Dollar Loss)



ANNUAL RESIDENTIAL FIRE SPRINKLERS








Facilities

A fire station supports the needs of the Fire Department and the community in which it is located. It must accommodate extremely diverse functions, including housing, administration, training, community education, equipment and vehicle storage, equipment and vehicle maintenance, and hazardous materials storage. Our facilities are not only occupied by our own personnel, they also accommodate the general public, non-profit organizations and other government entities for training purposes, community education or outreach programs, etc.

Each fire station varies in design depending on when it was built, the types of emergencies that will be responded to, the types of equipment that will be housed at the station and the personnel it needs to accommodate.

All fire stations are operated 24 hours a day throughout the year and maintenance of these facilities continues to be challenging. Our fire stations are commercial buildings used as a residential housing for our Professional Firefighters. Since our stations are “on duty” 24/7, we stress the components to operate at that capacity. For example, the HVAC systems, boilers, and lighting components are used constantly. The Department is continuously maintaining and repairing these components and many others throughout the year. In 2018, the following major changes were made to our facilities:

- Station 91 located on Latrobe Road was upgraded from the original volunteer fire station to accommodate safety personnel to be housed 24 hours a day, 7 days a week. This remodel included upgrades to the interior and exterior of the building.
- Station 86 located on Bass Lake Road had an interior leak in one of the bathrooms, and therefore, required demolition and remodel to be completed.
- Station 92 located on Ryan Ranch Road is an unstaffed fire station but minor construction and updates have taken place in order to maintain the integrity of the building. At this time, this station is not a staffed fire station but is currently used for storage and community meetings.



Solar Power


