President Giraud called the meeting to order at 5:02 p.m. and Chief Johnson led the Pledge of Allegiance. Directors in attendance: Bennett, Durante, Giraud, Hartley, and White. Staff in attendance: Chief Johnson and Director of Finance Braddock. Counsel Cook was also in attendance.

VIII. COMMITTEE REPORTS

- A. Administrative Committee (Directors Bennett and Durante)** – No report.
- B. Finance Committee (Directors Giraud and White)**
 - 1. Review and approve Memorandum of Understanding with the El Dorado Hills Professional Firefighters pertaining to wages and benefits-** Continued to a Special Board Meeting
 - 2. Review and approve contracts with unrepresented employees pertaining to wages and benefits-** Continued to a Special Board Meeting
 - 3. Pension/OPEB Funded Status** – Director of Finance Braddock gave an overview of the District’s Pension and OPEB funded status as of the 6/30/2018 valuation date.
 - 4. District Reserve Policy Review** – Director of Finance Braddock reported that Staff would be bringing a proposed amendment to the District’s Reserve Policy back to the Finance Committee and full Board for approval. The amendment is intended to reflect a more realistic goal for the District in funding its OPEB liabilities.

IX. FIRE CHIEF’S REPORT – Chief Johnson reported to the Board on the following topics:

- A donation was received from West Sacramento Fire Department of 7 radios valued at roughly \$24,000
- Staff has interviewed several architects for the Training Center project and will bring to the Board a recommendation for an RFP award. Director Bennett asked that the recommendation be brought to the Administrative Committee prior to the full Board, and all agreed.
- The Engineers’ Exam was completed and Chief interviews are scheduled, after which a list will be published and emailed out to the Department
- Leslie Hobert was selected for the Community Risk Reduction Technician position
- Laura Lovel has started as a temporary Office Technician

- Fire Inspector I/II interviews are scheduled
- Fire Prevention month is underway, and crews have been visiting schools
- Smoke Detector giveaway is scheduled at the Four Seasons community for Saturday, October 19th

X. OPERATIONS REPORT

- A. Operations Report (Receive and file)** – Chief Hall reported that aerial training was completed last month, and it went well. He further reported on two specific incidents that occurred almost simultaneously during the month, including a vegetation fire in the Latrobe area and a structure fire in El Dorado Hills. He commended the crews for the outstanding job on these incidents. He also recognized Battalion Chief Moreno for his outstanding customer service.
- B. Review and update regarding Joint Powers Authority** – Chief Johnson reported that the JPA held a finance workshop to discuss how each agency will calculate the true cost of the ambulance.

XI. FISCAL ITEMS

- A. Review and approve Resolution 2019-11 fixing the employer contribution at an equal amount for employees and annuitants under the Public Employees' Medical and Hospital Care Act** – Continued to a Special Board Meeting

XII. NEW BUSINESS

- A. Review and approve the facility lease agreement for the Employee Development Center** – Chief Johnson presented a summary of the proposed lease terms. Director White expressed concern over the lack of a business plan for this facility and stated there was not adequate time for the Board to review the lease terms prior to this meeting. Director Durante suggested this item be referred to the Finance Committee for further review. Counsel Cook stated his concern over how the County would answer the question of whether Development Impact Fee funds could be used to pay for the lease. Director White asked if it was standard practice for the Board to approve a summary of lease terms without having the actual lease. Mark Ali, President of Local 3604, expressed concern over the fiscal impact of this lease and asked the Board to be cognizant of the financial forecast and the potential of a future economic downturn. Director Hartley suggested the item be referred to the Finance Committee and then could potentially be brought back at a Special Board Meeting. The other Directors concurred.

Director Hartley made a motion to refer this item back to Finance Committee to explore the details of the contract and review the business plan for the facility. The motion was seconded by Director Durante and unanimously carried.

- B. Ordinance 2019-01 Adopting the 2019 Fire Code, as amended; Introduction and First Reading of Ordinance; Set Public Hearing for November 21, 2019** – Fire Prevention Specialist Marshall Cox presented the 2019 Fire Code and explained the process for reviewing the proposed ordinance. He also requested to set a public hearing for ordinance adoption for the next regular Board meeting.

Director White made a motion to adopt the 2019 Fire Code as amended and set a Public Hearing for adoption of the Ordinance for November 21, 2019, seconded by Director Durante and unanimously carried.

- C. Review and approve Resolution 2019-12 approving the agreement to hire Retired Annuitant Ron Phillips as interim Fire Marshal/Division Chief** – Chief Johnson explained that CalPERS law requires a resolution be passed to hire a retired annuitant to fill a vacant position. The proposed resolution is to appoint Chief Ron Phillips to fill the vacancy of Fire Marshal/Division Chief.

Director Hartley made a motion to Adopt Resolution 2019-12 approving the agreement to hire Retirement Annuitant Ron Phillips as interim Fire Marshal/Division Chief, seconded by Director Durante, and unanimously carried. (Roll Call: Ayes: 5; Noes: 0)

President Giraud called the meeting to order at 4:00 p.m. and Chief Johnson led the Pledge of Allegiance. Directors in attendance: Bennett, Durante, Giraud, Hartley, and White. Staff in attendance: Chief Johnson and Director of Finance Braddock. Counsel Cook was also in attendance.

Meeting adjourned to closed session at 4:01 p.m.

The meeting reconvened at 4:48 p.m. The Board took no action during closed session.

III. ORAL COMMUNICATIONS

- A. **EDH Professional Firefighters** – Matt Eckhardt, Vice President, reported that the strike teams have returned home from deployment and reminded the Board that the annual Golf Tournament is scheduled for December 2nd. He also stated he is hopeful that the Board approves the contract tonight.

IV. COMMITTEE REPORTS

A. Administrative Committee (Directors Bennett and Durante)

1. **Review and approve architectural service RFP award to Ross Drulis and Cusenbery and WLC** – Deputy Chief Hall reported nine proposals were received and reviewed, and the top three firms were invited to complete a presentation. The Training Facility Committee (including DC Hall, BC Johnston, Tommy Abercrombie, and Craig Fernandez from Robbelen) unanimously selected Ross Drulis and Cusenbery (“RDC”) and WLC Architects (“WLC”).
2. **Review and approve Master Services Agreement for Training Center architect** – Chief Hall reported that RDC is best fitted for the Training Facility and larger scale, complex projects. Chief Johnson mentioned that the other local firms were not able to handle the complexity of this project.
3. **Review and approve Master Services Agreement for future architectural services** – Chief Hall explained that the Training Facility Committee agreed that WLC would be the best suited firm to assist the District with remodels and smaller future projects.

Director Bennett added that the presentations submitted by the firms were also reviewed by the Administrative Committee. Director Durante complimented the Training Facility Committee on their preparation and selection process. Director White asked about the maximum dollar amount that could potentially be spent under these Master Services Agreements without Board approval. Chief Hall explained that each contract is not to exceed \$2 million. Director of Finance Braddock explained that spending is limited to what the Board approves during the budget process. Any unbudgeted spending greater than \$25k must be brought to the Board for approval. Chief Hall explained the committee is very sensitive to the timeline and its intent is to keep the board in the loop. Director White requested that these type of documents and agreements are given to the Board earlier in the future so they have ample time to review.

Director Durante made a motion to approve architectural service RFP awards to Ross Drulis and Cusenbery and WLC Architects, as well as a Master Services Agreement with Ross Drulis and Cusenbery for Training Center architectural services and a Master Services Agreement with WLC Architects for future architectural services. The motion was seconded by Director Bennett, and unanimously carried. (Roll Call: Ayes: 5; Noes: 0)

B. Finance Committee (Directors Girauo and White)

1. **Review Staff Memo summarizing the proposed Memorandum of Understanding for Local 3604 and the Unrepresented Safety**

Management, Non-Safety Management, and Non-Safety Administrative Support Employee Salary and Benefits – Chief

Johnson recognized Local 3604 and Staff for all their hard work on this agreement. Director White complimented the collaborative effort of all parties on the negotiating teams and stated the presented documents are solid and a good foundation for future contracts. Engineer Gygax apologized for any delays toward the end of the process and explained the desire to get everything right the first time and make sure the District was not exposed. Engineer Gygax then personally thanked Director of Finance Braddock for her help in the process.

2. **Review and approve Resolution 2019-13 approving the El Dorado Hills Professional Firefighters Memorandum of Understanding –** Chief Johnson explained the Resolution was to codify and acknowledge all the items in the MOU which is an industry standard is to solidify these types of agreements by an adopted resolution.

Director White made a motion to approve Resolution 2019-13 adopting the El Dorado Hills Professional Firefighters Memorandum of Understanding, seconded by Director Durante, and unanimously carried. (Roll Call: Ayes: 5; Noes: 0)

3. **Review and approve Resolution 2019-14 approving Salary and Benefits for Unrepresented Safety Management, Non-Safety Management and Non-Safety Administrative Support employees**

Director White made a motion to approve Resolution 2019-14 adopting the Salary and Benefits for Unrepresented Safety Management, Non-Safety Management and Non-Safety Administrative Support employees, seconded by Director Bennett, and unanimously carried. (Roll Call: Ayes: 5; Noes: 0)

V. FISCAL ITEMS

- A. **Review and approve Resolution 2019-11 fixing the employer contribution at an equal amount for employees and annuitants under the Public Employees' Medical and Hospital Care Act –** Director of Finance Braddock explained the proposed resolution is to reflect what was just approved in the MOU and Unrepresented Employee resolutions with regard to District healthcare contributions. The resolution amends the Health contract with CalPERS and is effective January 1, 2020. Counsel Cook clarified that the EDHFD Board is considered the 'Executive Body' and CalPERS Board is the 'Board' as referred to in the resolution.

Director Bennett made a motion to approve Resolution 2019-11 fixing the employer contribution at an equal amount for employees and annuitants under

the Public Employees' Medical and Hospital Care Act, seconded by Director White, and unanimously carried. (Roll Call: Ayes: 5; Noes: 0)

- B. Review and approve updated Public Salary Schedule effective 10/8/2019** – Director of Finance Braddock stated that the updated Public Salary Schedule is to reflect the changes adopted in the MOU and Unrepresented Employee Resolutions.

Director Bennett made a motion to approve updated Public Salary Schedule effective 10/8/2019, seconded by Director White, and unanimously carried.

VI. OLD BUSINESS

- A. Review and Approve Interim Training Facility Lease** – President Giraudo stated he and Director White went through the lease agreement during the Finance Committee meeting and Chief Johnson answered their questions. He further stated the lease document has been reviewed by Counsel Cook.

Director Durante requested that the Board and committee revisit the finances and develop a business plan for this facility. Chief Johnson explained that a business plan was completed as part of the larger Training Facility project. Director White stated that while business plans are common in private industry, they are not required for the public sector. Director Bennett commented that she did not see the need for a business plan as the intent of a Training Facility is to train and keep our personnel safe; it is not meant to be an enterprise endeavor for revenue generation. Director Hartley commented that the lease will help meet the safety training requirements for our staff and keep our existing room at Station 85 available, which benefits the community. President Giraudo stated the Board will not require a business plan.

Director Hartley made a motion to approve the Interim Training Facility Lease, seconded by Director White. (Roll Call: Ayes: 4; Noes: 1 (Durate))

VII. ADJOURNMENT

Director White made a motion to adjourn the meeting, seconded by Bennett, and unanimously carried.





Annual Report – 2018/2019
El Dorado Hills Joint County Water/Fire District-Latrobe Zone

The special tax measure passed under Government Code Section 50075 by the voters in the Latrobe Fire Protection District, now the El Dorado Hills County Water District, was specifically intended to develop and maintain fire and rescue services in the Latrobe Community. The measurement adopted to evaluate the success of the additional funds in the fire district was to accomplish and maintain an ISO rating for the District. Prior to this time, the District was unrated and the homeowners were subject to high homeowner insurance rates. All funds have been assigned each year to the annual operating budget for purchase and maintenance of rescue and firefighting equipment and apparatus. The district accomplished an ISO rating in the first year following the voter approval tax measure. El Dorado Hills Joint County Water/Fire District continues to maintain this ISO rating with the assistance of the special tax funding.

During fiscal year 2018/19, the funds collected by the special tax were \$35,907. The funds expended for Services and Supplies totaled \$1,450,576 of which the excess over and above the special tax was funded by annual property taxes.

There are no projects required or authorized to be funded under Section 50075.1 from this special tax.

TOPIC

Staff asks the Board to approve & adopt Ordinance 2019-01, locally amending the 2019 California Fire Code.

SUMMARY

At the regularly scheduled September board meeting, the Board approved the required Findings of Facts and held the first reading of the proposed ordinance. At the regularly scheduled October board meeting, the Board held the first reading of Ordinance 2019-01.

At this regularly scheduled November board meeting, which is a public hearing and has been noticed in accordance with the CA Health & Safety Code, the Board is to hold a second reading, provide their comments, hear any comments given to the district by the public or other county agencies/committees, and adopt Ordinance 2019-01 as written, or as amended by the Board.

DISCUSSION

The process and timeline for the Rescue Fire Department Fire Code adoption complies with the Health & Safety Code Sections 13869.7, 17958.7, and 18941.5. 

ORDINANCE NO. 2019-01

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE EL DORADO HILLS COUNTY WATER DISTRICT AS FOLLOWS:

An ordinance of the El Dorado Hills County Water District (EDHCWD) adopting the 2019 Edition of the *California Fire Code*, incorporating the 2018 Edition of the *International Fire Code*, regulating and governing the safeguarding of life and property from fire and explosion hazards arising from the storage, handling and use of hazardous substances, materials and devices, and from conditions hazardous to life or property in the occupancy of buildings and premises in the EDHCWD; providing for the issuance of permits and collection of fees therefor; Repealing Ordinance No. 2016-37 of the EDHCWD and all other ordinances and parts of the ordinances in conflict therewith.

Be it ORDAINED by the Board of Directors of the EDHCWD, also known as the El Dorado Hills Fire Department:

SECTION 1: FINDINGS OF FACTS

The EDHCWD makes certain changes (listed below) to the *California Fire Code*, 2019 Edition, pursuant to *Health & Safety Code Sections 13869.7, 17958.7 and 18941.5* during this code adoption process. Such changes are necessary because of local climatic, geological and/or topographical conditions. The EDHCWD has adopted, pursuant to *Section 18941.5* of the *California Health & Safety Code*, the findings of facts relative to these conditions by Resolution #2019-10 of the EDHCWD dated September 19, 2019.

SECTION 2: ADOPTION OF CODE WITH EXCLUSIONS

The EDHCWD adopts the 2019 *California Fire Code*, Title 24, Part 9, **in its entirety**, including Appendices, incorporating those sections of the *International Fire Code*, 2018 edition not adopted by the state, with the exclusions listed below:

Exclusions: 105.6.17-105.6.19, 105.6.39, 308.1.4, 309, 311.5, 311.6, 318, 403.1, 403.2.1-403.2.4, 403.3, 403.4, 403.6, 403.7, 403.8 (adopting 403.8.1-403.8.1.7), 403.9, 403.10.2, 403.10.3, 403.11, 403.12, 404.1-404.4, 405.1-405.4, 405.6-405.9, 406, 805-807 (adopting 807.5.2), 808, 904.1.1, 1101, 1103.1, 1103.3-1103.6, 1103.9 (adopting 1103.9.1), 1103.10, 1104-1106, Chapter 25, Chapter 26, the exceptions under D104.2 (Exception), D106.1 (Exception), D107.1 (Exception), Appendix A, Appendix E, Appendix F, Appendix G, Appendix J, Appendix K, Appendix L, Appendix M.

Appendices not adopted can be used for reference in enforcing other sections of the 2019 *California Fire Code*.

SECTION 3: LOCAL AMENDMENTS

The following Sections are hereby amended or added:

Chapter 1

- **Section 101 Scope and General Requirements**

- **101.1 Title** shall be amended as follows: *Add name of jurisdiction [EDHCWD]*

- **Section 106 Fees**

- **106.6 Permit, Plan Review and Inspection Fees** shall be added as follows: *A schedule of fees adopted by the district board of directors for plan review, inspections and the issuance of permits by the district may be found in the most current district fee schedule (Health & Safety Code 17951).*

- **106.6.1 Cost Recovery Fees** shall be added as follows: *Fire service fees may be charged to any person, firm, corporation or business that through negligence, violation of the law, or as a result of carelessness, is responsible for the cause of the district to respond to the scene of an incident. A district board may charge a fee to cover the cost of any service which the district provides or the cost of enforcing any regulation for which the fee is charged (Health & Safety Code 13916). The fee shall not exceed the actual cost of suppressing the fire and/or responding to the scene of an incident.*

- **106.7 Administrative Costs** shall be added as follows: *When a test or inspection is scheduled, and the contractor fails to perform to the satisfaction of the authority having jurisdiction (AHJ), the AHJ may bill the contractor for actual time spent traveling to and from the test/inspection location and the time spent at the test/inspection site as well as administrative costs.*

- **Section 109 Board of Appeals**

- **Section 109.4 Appeal Procedures and Timelines** shall be added as follows: *Any person or entity who believes they may be adversely affected by an order, decision, or determination made by the fire code official through a written notice may appeal this matter within 15 calendar days of the postmark on*

the notice. All such appeals shall be filed in writing with the Secretary of the Governing Board for the district. A timely appeal shall stay further action by the fire code official until the matter is determined by the Appeal Board as outlined in Section 109.2, unless the issue poses an imminent fire or life safety hazard to members of the public. The fire code official shall notify the appellant by certified mail of the date and time of such hearing. The hearing shall be scheduled to take place no sooner than 20 calendar days from the date shown on the certified mail. The appellant shall have the right to appear in person or by agent at the hearing and present oral, written and/or photographic evidence to the Appeal Board.

- **Section 110 Violations**

- **110.4 Violation Penalties** shall be amended as follows: Persons who shall violate a provision of this code or shall fail to comply with any of the requirements thereof or who shall erect, install, alter, repair or do work in violation of the approved construction documents or directive of the fire code official, or of a permit or certificate used under provisions of this code, shall be guilty of a *misdemeanor or infraction, at the discretion of the prosecuting attorney or agency, punishable by a fine not exceeding \$100.00 for a first violation; 2. A fine not exceeding \$500.00 for a second violation of the same provision within one year; 3. A fine not exceeding \$1000.00 for each additional violation of the same provision within one year, or by imprisonment not exceeding 180 days, or both such fine and imprisonment. Each day that a violation continues after due notice has been served shall be deemed a separate offense. (Health & Safety Code Sections 13145 and 17995).*

- **110.4.2 Citations** shall be added as follows: *The Fire Chief, or his/her duly authorized representative, may issue citations for infractions or misdemeanor violations of this code pursuant to Section 13871 of the Health & Safety Code of the State of California and Chapter 5c (commencing with Section 853.6) of Title 3 of Part 2 of the Penal Code of the State of California.*

- **Section 112 Stop Work Order**

- **112.4. Failure to Comply** shall be amended as follows: Any person who shall continue any work after having been served with a stop-work order, except such work as that person is directed to perform to remove a violation or unsafe condition, shall be *punishable by a fine or imprisonment or both as described in Section 110.4 (Health & Safety Code Sections 13145 and 17995).*

Chapter 2

- **Section 202 General Definitions**

- Add definition for **Campfire** - *Shall mean a fire which is used for cooking, personal warmth, lighting, or aesthetic purposes. This includes fires contained within outdoor fireplaces and enclosed stoves with flues or chimneys, stoves using jellied, liquid, or solid fuels, portable barbecue pits, braziers, or*

space heating devices which are used outside of any structure, mobile home, or any living accommodation mounted on a vehicle.

- Add definition for **District** - *Shall mean the district and all other areas within the exterior boundaries thereof now or hereafter established.*
- Add definition for **Driveway** - *Shall mean a vehicular access that serves up to two (2) parcels with no more than two (2) residential units and any number of non-commercial or industrial buildings on each parcel.*
- Add definition for **Executive Body** - *Shall mean the Board of Directors of the District.*
- Add definition for **Fire Chief** - *Shall mean the Chief Executive Fire Officer of the Fire department/district serving the jurisdiction or a duly authorized representative.*
- Add definition for **Trained Crowd Manager** - *Shall mean standby personnel, usually a security guard or usher personnel, who are trained in the proper procedure to exit people from a tent or other place of public assemblage in an orderly and calm fashion in the event of an emergency.*

Chapter 3

Section 302 Definitions

- **302.1 Definitions** shall be amended as follows: Added Campfire definition, as shown above in Chapter 2.

Section 307 Open Burning, Recreational Fires, and Outdoor Fireplaces

- **307.4.4 Campfire Restrictions** shall be added as follows:

- **307.4.4.1** *It is unlawful for any person to light, maintain, or use a campfire upon or near any brush-covered land, grass-covered land, or forest-covered land during the time when burning permits are suspended by the Director of the Department of Forestry and Fire Protection, the CAL FIRE Unit Chief, or the AHJ.*

***Exception:** Commercial cooking operations with approval of the AHJ.*

- **307.4.4.2** *When campfires are allowed, it should be unlawful for any person to light, maintain, or use a campfire upon any brush-covered land, grass-covered land, or forest-covered land unless the following minimum requirements are complied with.*
- **307.4.4.2 (a)** *The area within 5 feet of the periphery of the campfire is cleared of all flammable material and vegetation.*
- **307.4.4.2 (b)** *One serviceable shovel with a handle of at least 12 inches is ready for use at the immediate area of the campfire.*
- **307.4.4.2 (c)** *Campfires shall be limited to a 1 foot by 1 foot area, unless in an approved manufactured cooking device or fire ring.*

- **307.4.4.2 (d)** *Written permission of the landowner must be obtained prior to the ignition of the campfire and shall be on site.*

Chapter 5

- **Section 503 Fire Apparatus Access Roads**
- **503.2.1 Dimensions** shall be amended as follows: Fire apparatus access roads shall have an unobstructed width of not less than 20 feet, exclusive of shoulders, *as measured from face of curb to face of curb*, except for approved security gates in accordance with Section 503.6, and unobstructed vertical clearance of not less than *15 feet*. *All driveways in the district shall not be less than 12 feet wide.*
- **503.2.5 Dead Ends** shall be amended as follows: Dead-end fire apparatus access roads *and driveways* in excess of 150 feet in length shall be provided with an approved area for turning around fire apparatus.
- **503.2.6 Bridges and Elevated Surfaces** shall be amended as follows: Where a bridge or an elevated surface is part of a fire apparatus access road, the bridge shall be constructed and maintained in accordance *with the current El Dorado County Transportation Division Bridge Standard or Appendix D of the current California Fire Code, whichever is more restrictive*. Bridges and elevated surfaces shall be designed for a live load sufficient to carry the imposed loads of fire apparatus. Vehicle load limits shall be posted at both entrances to bridges when required by the Fire Code Official. Where elevated surfaces designed for emergency vehicle use are adjacent to surfaces which are not designed for such use, approved barriers, approved signs, or both shall be installed and maintained when required by the fire code official.
- **503.4.2 No Parking in Fire Lanes** shall be added as follows: *No person shall stop, park, or leave standing any vehicle, whether attended or unattended, except when necessary to avoid conflict with other traffic or in compliance with the directions of the Fire Chief, or his/her duly authorized representative, Peace Officer or official traffic control device along the edge of any highway, at any curb, or in any location in a publicly or privately owned or operated off-street parking facility, designated as a fire lane by the district with jurisdiction over the area in which the place is located. The designation shall be indicated (1) by a sign posted immediately adjacent to, and visible from, the designated place clearly stating in letters not less than one inch in height that the place is a fire lane, (2) by outlining or painting the place in red and, in contrasting color, marking the place with the words "FIRE LANE", which are clearly visible from a vehicle, or (3) by a red curb or red paint on the edge of the roadway upon which is clearly marked the words "FIRE LANE".*
- **503.4.3 No Parking in Front of Hydrants** shall be added as follows: *No person shall stop, park, or leave standing any vehicle within 15 feet of a fire hydrant except as follows: (a) If the vehicle is attended by a licensed driver who is seated in the front seat and who can immediately move such*

vehicle in case of necessity, (b) If the vehicle is owned or operated by a fire department and is clearly marked as a fire department vehicle.

- **503.4.4 Fire Lanes Based on Road Width** shall be added as follows: *Fire lanes shall be based on road width as required in Appendix D as amended by the district.*
- **503.5.3 Fire Apparatus Access Gates** shall be added as follows: *All automatic and manual gates installed over fire apparatus access roads shall comply with the district gate standard as approved by the fire code official.*
- **Section 505 Premise Identification**
- **505.1 Address Identification** shall have the first line of this paragraph amended as follows: *Addresses for new and existing buildings shall comply with the district address standard as approved by the fire code official.*
- **Section 507 Fire Protection Water Supplies**
- **507.5.1 Where Required** shall be amended as follows: *400 feet shall be amended to 150 feet.*
- **Section 509 Fire Protection and Utility Equipment Identification and Access**
- **509.3 Fire Control Room** shall be added as follows: *Fire sprinkler risers, fire alarm control panels, solar photovoltaic power system rapid shutoff switches, and other fire detection, suppression or similar control elements shall be located inside a single fire control room for the building. The fire control room shall have minimum dimensions of five feet by seven feet in size with a total usable area of not less than 35 square feet. The room shall be located within the building on an outside wall at a location approved by the Fire Code Official and shall be accessible from the exterior. An exterior access door with a clear width of not less than 32 inches and height of not less than 80 inches shall be provided for access into the room. A durable sign shall be affixed to the exterior of the door with the words "FIRE CONTROL ROOM" in letters not less than 4 inches in height. A key box complying with Section 506 shall be installed on the exterior side of the fire control room door opening.*
- *The room must be capable of maintaining a minimum temperature of 40 degrees Fahrenheit. A clearance of 12 inches shall be provided from the fire sprinkler risers to any adjacent walls. This room can be a shared with other building utilities or fire protection equipment that is not incompatible. An approved cabinet or container shall be provided to store record plans of the fire sprinkler system and other fire protection equipment. This room shall not be used for any other storage.*

Exception: *One-and two-family dwellings, manufactured homes or similar uses defined as either a Group R-3, R3.1, or R-4 occupancy.*

Chapter 9

- **Section 903 Fire Sprinklers**

- **903.2 Where Required** shall be amended as follows: An approved automatic sprinkler system *shall be required and installed in new buildings and structures 3600 square feet or greater when constructed or relocated within the jurisdiction as described in Sections 903.2.1 through 903.2.12.*

Exception: Agricultural buildings not under a special use permit used for commercial purposes.

- **903.2.a Where Required** shall be added as follows: *Status of existing buildings greater than 3,600 square feet. In existing buildings 3,600 square feet or greater, other than one and two-family dwelling units, and agricultural buildings not under special use permit for commercial purposes, where the floor area of the building or structure is increased by an addition of more than thirty percent (30%) or 1,000 square feet whichever is less, such building or structure shall be made to conform to Section 903.2.*
- **903.2.b Where Required** shall be added as follows: *Status of existing buildings less than 3,600 square feet. In existing buildings 3,600 square feet or less, other than one-and two-family dwelling units, and agricultural buildings not under special use permit for commercial purposes, where the floor area of the building or structure is increased to a total square footage over 3,600 square feet, by an addition of more than thirty percent (30%) or 1,000 square feet, whichever is less, such building or structure shall be made to conform to Section 903.2.*
- **903.2.1 Group A** shall be amended as follows for A groups A-1 through A-4: 903.2.1.1 (1) The fire area exceeds 3,600 square feet.
- **903.2.3 Group E** shall be amended as follows: 903.2.3 (1) Throughout all Group E fire areas greater than 3,600 square feet in area.
- **903.2.4 Group F-1** shall be amended as follows: 903.2.4 Group F. 903.2.4 (1) A Group F fire area exceeds 3,600 square feet.
- **903.2.7 Group M** shall be amended as follows: 903.2.7 Group B and M. 903.2.7 (1) A Group B and M fire area exceeds 3,600 square feet.
- **903.2.8.2 Manufactured Homes** shall be added as follows: *An automatic fire sprinkler system shall be required in all new manufactured homes and multi-family manufactured homes intended for use as a one-and two-family dwelling. The design and installation of such systems shall be in accordance with California Code of Regulations, Title 25, §4300.*

Exceptions:

1. *Manufactured homes located within an existing mobilehome park complying with California Health and Safety Code, Division 13, Part 2.1 or 2.3.*

2. *Manufactured homes that do not exceed 1,200 square feet in size and serve as an accessory dwelling unit, as defined in Government Code Section 658502; when the existing primary residence on the property is not required to comply with California Residential Code Section R313.2.*
 3. *Manufactured homes that do not exceed 320 square feet in size.*
- **903.2.9 Group S-1** shall be amended as follows: 903.2.9 Group S. 903.2.9 (1) A Group S fire area exceeds 3,600 square feet.
 - **903.2.10 Group S-2 Enclosed Parking Garages** shall be amended as follows: 903.2.10 (1) Where the fire area of the enclosed parking garage exceeds 3,600 square feet.
 - **Section 907 Fire Alarm and Detection Systems**
 - **907.2.a Where Required – New Buildings or Structures less than 3,600 square feet** shall be added as follows: *An approved fire alarm/detection system shall be installed in all buildings with a floor area less than 3,600 square feet.*
 1. *One- and two-family dwellings (R-3 Occupancies and other occupancies classified as “U”).*
 2. *Agricultural buildings not under special use permit and/or not used for commercial purposes (e.g., retails sales, food service, and/or special events).*
 3. *Buildings with a floor area less than 500 square feet may be exempt, as determined by the Fire Chief, or his/her duly authorized representative, based on building construction material and features, location, occupancy type, and distance to exposures.*
 - **907.2.b Status of Existing Buildings** shall be added as follows: *In existing buildings without an approved automatic sprinkler system, other than one- or two-family dwelling units, agricultural building not under special use permit for commercial purposes where a fire alarm detection system does not exist and the floor area of the building or structure is increased or modified by more than thirty percent (30%) or 1,000 square feet, whichever is less, such building or structure shall be made to conform to Section 907 when required by the Fire Chief, or his/her duly authorized representative. Buildings with a floor area less than 500 square feet may be exempt, as determined by the Fire Chief, or his/her duly authorized representative, based on building construction materials and features, location, occupancy type, and distance to exposures.*
 - **907.2.c Monitoring** shall be added as follows: *All fire alarm/detection systems shall be connected directly through and monitored by a U.L. approved central, proprietary or remote station service, which gives audible and visual signals at a constantly attended location. All sprinklered buildings shall be monitored.*

Exceptions:

1. *One- and two-family dwellings (R-3 Occupancies and other occupancies classified as "U").*
 2. *Agricultural buildings not under special use permit and/or not used for commercial purposes (e.g., retails sales, food service, and/or special events).*
- **907.2.d Type I Hood Installations** shall be added as follows: *The requirement of installation, or replacement, of a Type I Hood System shall require a fire alarm/sprinkler monitoring system to be installed, or for the hood system to be connected to an existing fire alarm/sprinkler monitoring system for that building.*
 - **907.6.2.1 Secondary Power Supply** shall be added as follows: *In accordance with NFPA 72, the secondary power supply providing a minimum 24-hour power capacity under quiescent load (system operating in a non-alarm condition) shall be amended to a minimum 72-hour power capacity.*

Exception: The existence of an emergency back-up power supply that meets or exceed the requirements of California Fire Code Chapter 12.

Chapter 12

- **Section 1203 Emergency and Standby Power Systems**
- **1203.1.3 Installation** shall be amended as follows: *Emergency power systems and standby power systems shall be installed in accordance with the California Building Code, the California Electric Code, NFPA 110 and NFPA 111. All buildings, other than one- and two-family dwelling units, and agricultural buildings not used for commercial purposes, with standby power, shall have a shunt trip device that disconnects all power sources to the building, approved by the fire code official. Existing installations shall be maintained in accordance with the original approval.*

Chapter 33

- **Section 3310 Access for Firefighting**
- **3310.3 Premise Identification** shall be added as follows: *Prior to and during construction, an approved address sign shall be provided at each fire and emergency vehicle access road entry into the project.*
- **Section 3312 Water Supply for Fire Protection**
- **3312.1 When Required** shall be amended as follows: *Prior to combustible materials arriving on site, the fire hydrant water system shall be installed and maintained in continuous operation. The amount of water supplied shall meet the required fire flow for the project.*

Chapter 49

- **Section 4903 Plans**

- **4903.1 Where Required** shall be added as follows: *The fire code official of the EDHCWD may require development projects located in Moderate, High and Very-High Fire Hazard Severity Zones to submit fire protection plan. This plan shall be approved by both the fire code official and the authorized representative for the local CAL FIRE Unit Chief (if located in the State Responsibility Area [SRA]) prior to the recording of the final map for the project by the County of El Dorado.*

- **Section 4905 Wildfire Protection Building Construction**

- **4905.4 Roof Construction Requirements** shall be added as follows: *All new construction, including additions, requires a Class A roof covering or assembly. All re-roofing requires Class A roof covering or assembly as a minimum. Re-roofing in excess of 50% of an existing structure within any one year period will necessitate that the entire roof be a Class A roof covering or assembly as a minimum. Class B or C fire retardant treated and or non-treated wood shake or shingles are not approved as a roof covering material for Class A assembly.*

Chapter 50

- **Section 5001 General**

- **5001.7 Liability for Damages** shall be added as follows: *Any damages or cost resulting from the careless handling, spill or discharge of any hazardous materials shall constitute debt against any such person, firm or corporation causing such spill or discharge. This debt is collectible by the Fire Chief, or his/her duly authorized representative, in the same manner as in the case of an obligation under contract, expressed or implied.*

Chapter 56

- **Section 5601 General**

- **5601.2 Permit Required** shall be amended as follows: *Permits shall be required as set forth in Section 105.6 and regulated in accordance with this section. Where explosives permits are required, they shall be issued by the Fire Chief, or his/her duly authorized representative, and the El Dorado County Sheriff's Department. Where fireworks permits are required, they shall be issued by the Fire Chief, or his/her duly authorized representative, and the El Dorado County Board of Supervisors.*
- **5601.2.1 Documentation** shall be added as follows: *The AHJ shall have the authority to request documentation regarding all aspects of the fireworks presentation.*
- **5601.2.2 Proprietary Information** shall be added as follows: *The AHJ will protect all proprietary information.*

Chapter 57

- **Section 5704 Storage**
- **5704.2.9.6.1 Locations Where Above-Ground Tanks are Prohibited** shall be amended as follows:
Storage of Class I and Class II flammable liquids in above-ground tanks outside of buildings is prohibited *unless approved by the Fire Chief, or his/her duly authorized representative. When permitted by the Fire Chief, or his/her duly authorized representative, all above ground tank(s) or vault installations for the storage of Class I, II or III flammable and combustible liquids shall comply with those requirements as set forth by the California Fire Code. The California Fire Code shall also apply to installations other than motor vehicle fuel dispensing stations where above-ground storage is required.*
- **Section 5706 Special Operations**
- **5706.2.4.4 Locations Where Above-Ground Tanks are Prohibited** shall be amended as follows:
Storage of Class I and Class II flammable liquids in above-ground tanks outside of buildings is prohibited *unless approved by the Fire Chief, or his/her duly authorized representative. When permitted by the Fire Chief, or his/her duly authorized representative, all above ground tank(s) or vault installations for the storage of Class I, II or III flammable and combustible liquids shall comply with those requirements as set forth by the California Fire Code. The California Fire Code shall also apply to installations other than motor vehicle fuel dispensing stations where above-ground storage is required.*

Chapter 58

- **Section 5806 Flammable Cryogenic Fluids**
- **5806.2 Limitations** shall be amended as follows: Storage of flammable cryogenic fluids in stationary containers outside of buildings is prohibited *unless approved by the Fire Chief, or his/her duly authorized representative. When permitted by the Fire Chief, or his/her duly authorized representative, all stationary containers for the storage of flammable cryogenic fluids shall comply with those requirements as set forth by the California Fire Code. The California Fire Code shall also apply to installations other than motor vehicle fuel dispensing stations where above-ground storage is required.*

Chapter 61

- **Section 6104 Location of LP-Gas Containers**
- **6104.2 Maximum Capacity within Established Limits** shall be amended as follows: *The storage of liquefied petroleum gas in excess of an aggregate of 2,000-gallon water capacity when located at least one-half (1/2) mile from property zoned or designated for residential use and at least one-half*

(1/2) mile from existing residential development with a density greater than one (1) dwelling unit per acre and at least one-half (1/2) mile from any hotel or motel is allowed when AHJ approved, and a special/conditional use permit is issued by the County of El Dorado.

Dispensing within established limits. Within the limits established by law restricting the dispersion of liquefied petroleum gas for the protection of heavily populated or congested areas, the aggregate capacity of any one installation shall not exceed a water capacity of 2,000 gallons. The dispensing of liquefied petroleum gas in excess of an aggregate of 2,000-gallon water capacity when located at least one-half (1/2) mile from property zoned or designated for residential use and at least one-half (1/2) mile from existing residential development with a density greater than one (1) dwelling unit per acre and at least one-half (1/2) mile from any hotel or motel is allowed when AHJ approved and a special/conditional use permit is issued by the County of El Dorado.

- **Section 6113 Underground LPG Tanks Installations and Ownership** shall be added as follows:
- **6113.1 Permits and Plans** shall be added as follows: *Permits shall be required, and plans shall be submitted for all underground tank installations as approved by the AHJ.*
- **6113.2 Underground LPG Tank Ownership** shall be added as follows: *Underground LPG tanks shall be prohibited from being sold to end-users and shall be retained by the LPG company under a lease-type system to ensure proper annual maintenance requirements are met and recorded.*

Chapter 80

- **Section 80, NFPA, 13D-16 – Standard for the Installation of Sprinkler Systems in One-and Two Family Dwellings and Manufactured Homes as amended 903.3.1.3, 903.3.5**

Appendix D – Fire Apparatus Access Roads

Section D103 Minimum Specifications

- **D103.1 Access Road Width with a Hydrant** shall be amended as follows, adding the exception:
 - *Exception: Driveways*
- **D103.2 Grade** shall be amended as follows: Fire apparatus access roads and driveways shall not exceed *15.9% in grade unless approved by the AHJ or by the El Dorado County amended California Public Resource Code Title 14 / Design and Improvement Standards Manual.*
- **D103.3 Turning Radius** shall be amended as follows: The minimum turning radius shall be determined by the fire code official; *and shall not include curb and gutter.*
- **D103.5 Fire Apparatus Access Road Gates** shall be amended as follows: *Subsection (1): Where a single gate is provided, the gate width shall be not less than 20 feet (6096 mm). Where a fire apparatus road consists of a divided roadway, the gate width shall not be less than 15 feet (4572 mm).*
- **D103.6.1 Roads 20 to 29 feet in width** shall be amended as follows: Fire lane signs as specified in Section D103.6 shall be posted on both side of fire apparatus access roads that are 20 to 29 feet wide (6096 to 8534.4 mm).
- **D103.6.2 Roads more than 29 feet in Width** shall be amended as follows: Fire lane signs as specified in Section D103.6 shall be posted on one side of fire apparatus access roads more than 29 feet wide (8534.4 mm) and less than 36 feet wide (10972.8 mm).
- **D104.4 Circumferential Fire Apparatus Access Roads** shall be added as follows: *When required by the fire code official, a fire apparatus access road shall be constructed to encompass the entirety of a structure and shall provide a continuous means of emergency vehicle access.*

SECTION 4: CONFLICT

That Ordinance No. 2016-37 of the EDHCWD, and all other ordinances or parts of ordinances herewith are hereby repealed.

SECTION 5: SEVERABILITY

If any Ordinance, article, subsection or subdivision thereof, provision, sentence, clause or phrase of this code, or any application thereof, is for any reason held to be invalid by a court of competent jurisdiction, such decision shall not affect the remaining provisions of this code, which can be given effect without the invalid portions and, therefore, such invalid portions are declared to be severable. The EDHCWD hereby declares that it would have enacted this Ordinance and each of its articles, sections, subsections, or subdivisions thereof, provisions, sentences, clauses or phrases irrespective of the fact that one or more of them is declared invalid.

SECTION 6: EFFECTIVE DATE AND PUBLICATION

This Ordinance shall take effect thirty (30) days after its adoption. The EDHCWD Board Secretary is directed to publish this ordinance in a newspaper of general circulation in the District. In lieu of publication of the full text of the ordinance, a summary of the ordinance may be published by the by the Board Secretary within fifteen (15) days after its passage and a certified copy shall be posted in the office of the EDHCWD pursuant to *Government Code Section 36933(c) (1)*.

SUBJECT: California Health and Safety Code Sections 13146.2 - 13146.4 Compliance Report and Resolution

TOPIC

Staff recommends that the Board receive and adopt a resolution showing that for Calendar Year 2019 (CY 2019) the El Dorado Hills Fire Department (EDHFD) complies with California Health and Safety Code (HSC) Sections (§)13146.2, 13146.3 and 13146.4. These code sections require the Fire Chief, or their authorized designee, to inspect every building used as a public or private school within his jurisdiction, for the purpose of enforcing specified building standards, not less than once per year. This code section also requires the Fire Chief, or their designee, to demonstrate that all hotels, motels, lodging houses apartment houses and certain residential care facilities have been inspected annually for compliance with specified building standards. All buildings located within the jurisdiction of EDHFD that meet either definition have been inspected in CY 2019 by the Fire Chief or their designee.

DISCUSSION

After the tragic loss of life during the 2016 “Ghost Ship Fire” in Oakland CA the California legislature proposed amendments to certain provisions of HSC 13146 regarding the reporting of required annual inspections of specified buildings. See Attachment A regarding proposed code changes found in Senate Bill No. 1205 from the 2018 legislature. This bill was signed into law by Governor Brown on September 27, 2018. This bill was chaptered (854) into HSC §13146.4. See Attachment B regarding the applicable code provisions EDHFD must now demonstrate compliance with on an annual basis.

California HSC §13146.2 currently requires the Fire Chief of the district providing fire protection services of his designated representative to inspect all buildings used as a public or private school with his jurisdiction, for the purpose of certain fire and life safety building standards, through an inspection not less than once per year. HSC §13146.3 also currently requires the Fire Chief, or their authorized representative, to enforce specified fire and life safety building standards through an annual inspection of hotels, motels, lodging houses, apartment houses and certain residential care facilities. HSC §13146.4 now requires the district to report annually its compliance with HSC §13146.2 and §13146.3 through the adoption of a resolution or similar formal document.

FINDINGS/ANALYSIS

During CY 2019 EDHFD conducted fire and life safety inspections of all known public or private schools within our jurisdiction. Thirty-four (34) schools were inspected by staff members of EDHFD. At the conclusion of these inspections all school buildings were found to be in compliance with the relevant building standards of the State.

During CY 2019 EDHFD conducted fire and life safety inspections of all hotels, motels, lodging house's apartment house's and certain residential care facilities within our jurisdiction. Ten (10) such facilities were inspected by staff members of EDHFD. At the conclusion of these inspections all such buildings were found to be in compliance with the relevant building standards of the State.

POLICY COMPLIANCE

California Health and Safety Code §13146.4.

- (a) Every city or county fire department, city and county fire department, or district required to perform an annual inspection pursuant to Sections 13146.2 and 13146.3 shall report annually to its administering authority on its compliance with Sections 13146.2 and 13146.3.
- (b) The report made pursuant to subdivision (a) shall occur when the administering authority discusses its annual budget, or at another time determined by the administering authority.
- (c) The administering authority shall acknowledge receipt of the report made pursuant to subdivision (a) in a resolution or a similar formal document.

CONCLUSION

The district meets all requirements of HSC §13146.2 and §13146.3 in CY 2019. Staff recommends the approval of the attached resolution demonstrating compliance with HSC §13146.4 of all required building by the El Dorado Hills Fire Department this year.

FISCAL IMPACT

HSC §13146.4 requires the administering authority to acknowledge receipt of the report in a resolution or a similar formal document. To the extent this code section does expand the responsibility of a local agency, the section does create a State-mandated local program. The California Constitution requires the state to reimburse local agencies for certain costs mandated by the State. Statutory provisions establish procedures for making that reimbursement.

There is no current cost recovery for these building inspections as part of the EDHFD Fee Schedule.

RECOMMENDATION

Staff respectfully recommends the Board approve to receive and adopt a resolution showing compliance with California Health and Safety Code Section 13146.4 in CY 2019.



Senate Bill No. 1205 CHAPTER 854

An act to add Section 13146.4 to the Health and Safety Code, relating to fire protection.

[Approved by Governor September 27, 2018. Filed with Secretary of State September 27, 2018.]

LEGISLATIVE COUNSEL'S DIGEST

SB 1205, Hill. Fire protection services: inspections: compliance reporting. Existing law requires the chief of any city or county fire department or district providing fire protection services and his or her authorized representatives to inspect every building used as a public or private school within his or her jurisdiction, for the purpose of enforcing specified building standards, not less than once each year, as provided. Existing law requires every city or county fire department or district providing fire protection services that is required to enforce specified building standards to annually inspect certain structures, including hotels, motels, lodging houses, and apartment houses, for compliance with building standards, as provided.

This bill would require every city or county fire department, city and county fire department, or district required to perform the above-described inspections to report annually to its administering authority, as defined, on the department's or district's compliance with the above-described inspection requirements, as provided. The bill would require the administering authority to acknowledge receipt of the report in a resolution or a similar formal document. To the extent this bill would expand the responsibility of a local agency, the bill would create a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:

SECTION 1. Section 13146.4 is added to the Health and Safety Code, to read:

13146.4. (a) Every city or county fire department, city and county fire department, or district required to perform an annual inspection pursuant to Sections 13146.2 and 13146.3 shall report annually to its administering authority on its compliance with Sections 13146.2 and 13146.3.

(b) The report made pursuant to subdivision (a) shall occur when the administering authority discusses its annual budget, or at another time determined by the administering authority.

(c) The administering authority shall acknowledge receipt of the report made pursuant to subdivision (a) in a resolution or a similar formal document.

(d) For purposes of this section, "administering authority" means a city council, county board of supervisors, or district board, as the case may be.

SECTION 2.

If the Commission on State Mandates determines that this act contains costs mandated by the state, reimbursement to local agencies and school districts for those costs shall be made pursuant to Part 7 (commencing with Section 17500) of Division 4 of Title 2 of the Government Code.

SUBJECT: Board Authorization to Obtain Criminal Record History Information From the Department of Justice for Employment Purposes

TOPIC

Accessing state and federal level criminal history information from the Department of Justice for employment purposes.

SUMMARY

Staff seeks Board authorization to access state and federal level criminal history information from the Department of Justice for employment purposes.

DISCUSSION

Penal Code section 11105(b)(11) authorizes a city, county or special district to request criminal record information from the Department of Justice (DOJ) in order to assist in fulfilling employment. The DOJ requires that the governing board of the city, county, or district authorize the agency to access state and federal level criminal history information before criminal history access will be granted by the DOJ.

Once access is authorized, state and federal level criminal history information will be available through the DOJ Live Scan system. A Live Scan is a system for the electronic submission of a candidates fingerprints and the subsequent automated background and criminal history verification. Candidates that are in the pre-employment phase of the hiring process would be required to complete a Live Scan fingerprint analysis as part of their background investigation. The DOJ would then retain the fingerprints on file for subsequent arrest notifications pursuant to Penal Code section 11105.2.

Conducting Live Scan fingerprinting during the pre-employment background investigation process is crucial in identifying criminal activity and convictions in the candidates past. Having knowledge of such criminal activity and convictions before and after the candidate is hired will assist in limiting departmental liability and also help ensure the safety of employees, members of the public, and any others that the candidate would come in contact with during the course of the job.

FISCAL IMPACT

There is no fiscal impact.





WHEREAS, Penal Code Sections 11105(b)(11) and 13300(b)(11) require that there be a requirement or exclusion from employment, licensing, or certification based on specific criminal conduct on the part of the subject of the record; and

WHEREAS, Penal Code Sections 11105(b)(11) and 13300(b)(11) require the city council, board of supervisors, governing body of a city, county, or district or joint powers authority to specifically authorize access to summary criminal history information for employment, licensing, or certification purposes.

NOW THEREFORE, BE IT RESOLVED, that the El Dorado Hills County Water District is hereby authorized to access state and federal level summary criminal history information for employment (including volunteers and contract employees) and may not disseminate the information to a private entity.

El Dorado Hills Fire Department developed an request for proposal (RFP) requesting a formal proposal from qualified independent communication engineers to evaluate the Department's current radio communications system, analyze three different options (CAL Fire – Camino, Sacramento Regional Fire/EMS Communications Center, and a standalone dispatch center owned and operated by the Department), and provide an official report outlining all of the benefits and risks associated with each option. The deadline for submittal was Friday, November 1, 2019.

DISCUSSION

El Dorado Hills Fire Department received a total of four proposals, all of which were considered compliant to the requirements outlined in the RFP. The four firms that submitted a proposal were:

- Federal Engineer
- CSI Telecommunications, Inc.
- Scientel Solutions
- ACD Telecom

After a thorough review and a rating of each proposal by a panel of three department administrative staff, we would like to recommend the agreement to provide scope of work described in the RFP to Federal Engineering. This firm most demonstrated the qualifications, experience, and value that the Department is seeking.

FISCAL IMPACT

The quoted cost for the recommended services contract is **\$105,864.00**. The necessary funds were budgeted into the current budget, 2019/20 F.I. of \$110,000.00.

RECOMMENDATION




