The meeting adjourned at 7:42 p.m.

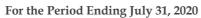

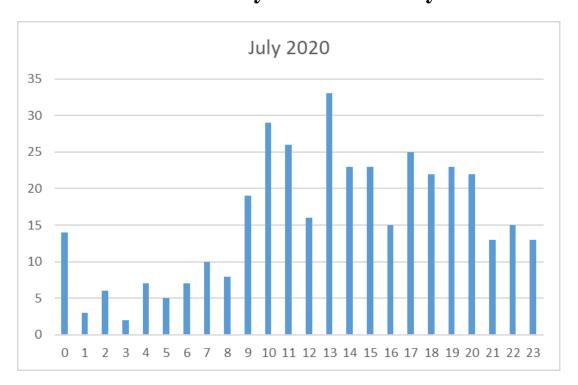
TRAINING DIVISION UPDATE

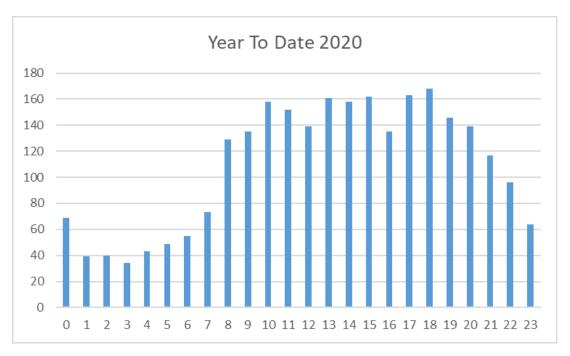
In the month July, EDH Fire personnel participated in the following drills/training;

- Multi-company and single company training evolutions.
- Building Walk-through Personnel took advantage of walking through different buildings to become more familiar with the different challenges each present.
- Low Angel Rope Rescue Operations (LARRO) Training Participating in this training, provides members the opportunity to maintain currency in the LARRO discipline.
 Members work with ropes/webbing, stokes basket, identification of anchors, and build mechanical advantage ropes systems, to mention a few. This helps to ensure members have the necessary skills and knowledge to be an effective team member when called to assist the public.
- Rural Hose Operations Participants worked through different scenarios and challenges associated with providing a continuous water supply to stabilize and extinguish the different fires that occur throughout the Department's jurisdiction.

Incidents by Hour of the Day

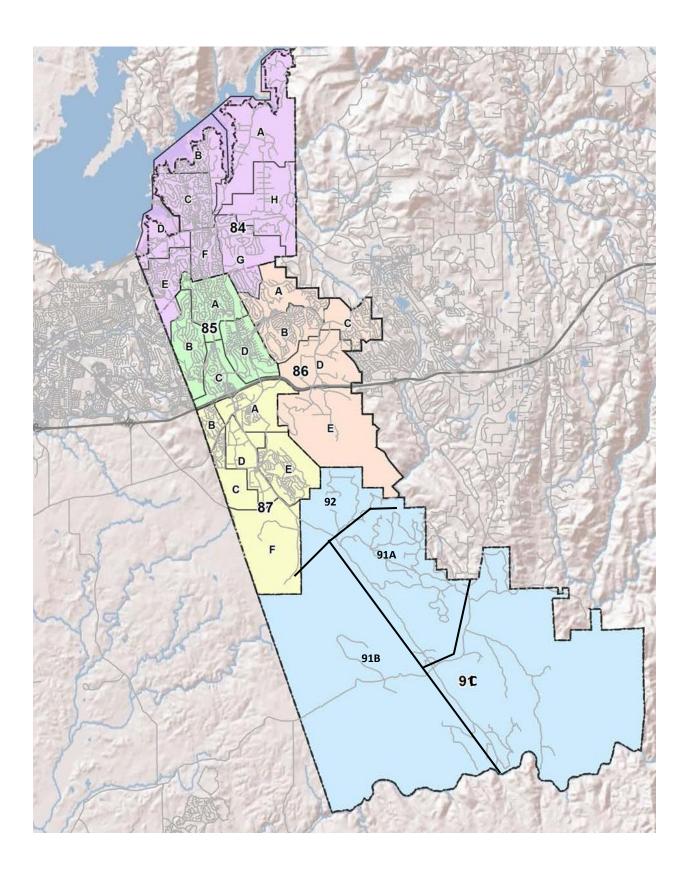

Brandon Vegetation Fire

On July 7, 2020, crews from the EDH Fire Department along with CAL Fire, Rescue Fire Department, Garden Valley Fire Department, US Forest Service, and the BLM responded to a vegetation fire off Brandon Rd. Engine 91 was the first fire resource on scene with approximately 1 to 3 acre grass fire. The fire grew to approximately 33 acres, no injuries to civilian or fire personnel.









Hog Fire

Strike Team 4077C Assignment

In the early morning hours of July 20, 2020, EDH Fire deployed Engine 386 with Captain Laundry, Engineer Austerman, and Firefighters VanDalen and Netherton as part of a Type III strike team to the Hog Fire near Susanville and was led by Strike Team Leader Chief Moreno. The agencies represented on this deployment were Georgetown, Garden Valley, Diamond Springs, Alpine County, and El Dorado Hills Fire. The team left in the early morning hours of July 20th and returned on July 30th. While deployed, the crews participated in activities ranging from structure protection to mop-up. During their deployment, each agency was well represented by hardworking professional individuals, who worked long hard hours. We are proud of their hard work and their representation and glad they all made it back home safely.

OES 5264 Mobile Command Vehicle (MCV)

In early July, the OES and the EDH Fire entered into an agreement for an MCV. These vehicles are used by OES to manage the local government assets that are on fires throughout the State. The vehicle is outfitted with communications equipment, computers, office space, to mention a few, designed to function as a command center.

Even though it was a little early than expected, the MCV was requested and responded to the Hog Fire on July 21, 2020. Initially the unit was staffed with Captain MacKenzie and a representative from the Sacramento Region where OES 5264 came from and then later Engineer Leduc was sent to assist. For the first time out as an OES/EDH resource, the vehicle and personnel function at a high level and both EDH Fire and SRFECC were well represented. Total deployment was from July 21st and they returned on July 31st.

Fireline Paramedic (EMPF)

On July 22, 2020, EDH Fire deployed an overhead assignment to the Hog Fire, EMPF Kevin Schlange. During the deployment, FF Schlange worked on multiple divisions of the fire, where he provided medical assistance and support to the operations. Total deployment was from July 22nd to July 31st.

RESOLUTION ADOPTING THE APPROPRIATION LIMITS FOR THE 2020-21 FISCAL YEAR

WHEREAS, the Board of Directors conducted a hearing on the appropriation limitation for the El Dorado Hills County Water District on Thursday, August 20, 2020; and,

WHEREAS, the hearing was advertised and noticed as required by law; and,

WHEREAS, the Board received testimony and other evidence regarding the appropriation limitation to be established for the El Dorado Hills County Water District.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Directors of the El Dorado Hills County Water District, that the El Dorado Hills County Water District appropriation limit for the 2020-21 fiscal year, as described in Article XIII B of the State Constitution and implemented by Chapter 1205, Statutes of 1980 is the sum of \$47,599,783 computed as follows, \$44,306,416 X 1.07433161 = \$47,599,783.
